Board Update: The Chair called to order the action item of approving the 2020 Annual Meeting Minutes + Share Board Stipend for 2020 (required per Bylaws). 20 out of 22 voted to APPROVE the meeting minutes. 0 out of 22 voted NO. 2 out of 22 ABSTAINED. The Chair shared the Board Compensation: \$1,409 stipend and \$0 in reimbursements. The first owner engagement opportunity, via Slido, was presented. Each Director proceeded with an introduction and board highlight. Another Slido engagement opportunity concluded this section of the presentation.

**6:20 pm 2021 Board Election: + SEED Program Announcement:** Lori Ashmore, Board Director and Chair of the Election Committee, discussed the 2021 election results

and introduced the full Board. The winners of this election were Carla McCullough (Incumbent), Amanda McKay, and Jarvis Green. The election saw 5 candidates run for 3 available seats. The 2021 SEED program has received \$18,600+ in donations so far.
